Page 9, add after line 33:

(iv) research and analysis of diversity and inclusion matters within the jurisdiction of the Committee, including data related to recruitment, retention, and promotion issues, and the impact or probable impact of equal opportunity policies and practices affecting sectors within the jurisdiction of the Committee.

Page 3, strike line 14 and insert:

(b)(1) For the purpose of taking testimony and receiving evidence, two members of the Committee shall constitute a quorum, one of which shall be from the minority.

Page 5, strike line 39 and insert the following:

Such notice shall include a full copy of the proposed subpoena, including any proposed document schedule.

Page 5, insert the following after line 38:

(e)(4) Not more than 24 hours after the issuance of a subpoena by the Chair pursuant to this authority, a notice shall be made publicly available on the Committee website indicating the date and time the subpoena was issued. Such notice shall include a copy of the subpoena. The Chair shall consult with the Ranking Member in advance on any redactions that may be necessary.

Page 4, Line 21, insert at the beginning the following:

“Not less than 10 days prior to the commencement of the hearing, the Chair shall consult with the Ranking Member on the subject matter, witnesses, and other matters relating to the hearing.”

Page 1, Line 26, strike "Rule 2" and insert new section (d):

"(d) The Committee rules shall be made publicly available in electronic form on the Committee website and published in the Congressional Record not later than 10 legislative days after the Committee adopts its rules in each odd-numbered year. Every invitation to testify or subpoena to appear before the Committee shall be accompanied by a copy of the Committee's rules.
