1	SEC. 2. REPORT ON THE PROTECTION OF BENEFICIAL
2	OWNERSHIP INFORMATION DISCLOSED BY
3	FINCEN.
4	Section 5336(c)(2) of title 31, United States Code,
5	is amended by adding at the end the following:
6	"(D) Report to congress.—FinCEN
7	shall issue an annual report to Congress stat-
8	ing—
9	"(i) the number of times law enforce-
10	ment agencies and financial institutions
11	have accessed beneficial ownership infor-
12	mation pursuant to subparagraph (B);
13	"(ii) the number of times beneficial
14	ownership information reported to
15	FinCEN pursuant to this section was inap-
16	propriately accessed, and by whom; and
17	"(iii) the number of times beneficial
18	ownership information was disclosed under
19	subparagraph (B)(i)(II) pursuant to an au-
20	thorization from a court of competent ju-
21	risdiction.".
22	SEC. 3. CONSOLIDATION OF REPORTS.
23	(a) IN GENERAL.—Section 5336(b)(1) of title 31,
24	United States Code, is amended by adding at the end the
25	following:
26	"(H) Consolidation of reports.—

1	"(i) IN GENERAL.—In lieu of submit-
2	ting a report described under subpara-
3	graph (A) through (E), the Secretary shall
4	permit a reporting company to provide the
5	information required to be included in such
6	report in any other report the reporting
7	company is required to submit to the Sec-
8	retary, if such submission would—
9	"(I) facilitate compliance with
10	the reporting requirements under this
11	paragraph; and
12	"(II) serve the purposes de-
13	scribed under subsection $(c)(5)(B)$ .
14	"(ii) Rule of construction.—The
15	Secretary may provide the information de-
16	scribed under clause (i) to the Financial
17	Crimes Enforcement Network for the pur-
18	pose of investigating money laundering or
19	terrorist financing.".
20	(b) Conforming Amendments.—Section 5336 of
21	title 31, United States Code, is amended—
22	(1) in subsection $(b)(4)(B)(ii)$ , by striking
23	"FinCEN" and inserting "the Secretary";
24	(2) in subsection (d)(2), by striking "FinCEN"
25	and inserting "the Secretary"; and

2	(A) in paragraph (1), by striking
3	"FinCEN" each place such term appears and
4	inserting "the Secretary";
5	(B) in paragraph (2), by striking
6	"FinCEN" each place such term appears and
7	inserting "the Secretary";
8	(C) in paragraph (3)(C)(ii), by striking
9	"FinCEN" and inserting "The Secretary"; and
10	(D) in paragraph (4)(B)(ii), by striking
11	"FinCEN" each place such term appears and
12	inserting "the Secretary".
