Dear Chairman Cole, Ranking Member DeLauro, Chairman Amodei, and Ranking Member Clyburn:

As you consider the Fiscal Year (FY) 2026 Transportation, Housing and Urban Development, and Related Agencies (THUD) appropriations bill, I urge you to help address our nation's worsening affordable housing and homelessness crisis by appropriating \$150 billion for an emergency infusion of funds well above the FY2024 level for all HUD accounts in line with my bill, the "Housing Crisis Response Act." By passing this funding, Congress would also soundly reject President Trump's efforts to undermine the Department of Housing and Urban Development and its important programs that serve millions of Americans, while also making good on this Administration's promises to increase supply and bring down the cost housing.

For several years now, data from the U.S. Bureau of Labor Statistics has shown that housing inflation remains a key driver of core inflation. A chronic undersupply of housing has pushed rents and mortgages up by 50% and 60%, respectively since 2019. As wages have failed to keep pace with housing inflation, evictions and homelessness continue to rise. Meanwhile, Trump's tariff wars stand to make matters worse by tanking the U.S. financial markets and pushing up mortgage rates, the cost of building materials, and house prices. In fact, house prices are up by over 4% compared to this time last year and the median age of first-time homebuyers has reached an all-time high of 38 years old, compared to 20 years old in 1980. When millions of Americans are locked out of fair and affordable housing opportunities, our nation suffers. To address these concerning trends that are straining families' budgets, we must address the underlying affordable housing and homelessness crisis—one of the worst in our nation's history. Yet, federal housing investments as a share of total U.S. spending have steadily declined over the last decade—representing less than 1% of regular annual appropriations since 2019 and less than 2 percent since 1986.

To make matters worse, the Trump Administration's FY 2026 budget request proposes a devastating \$33 billion cut to housing programs, nearly 44% of HUD's budget. The budget request would eliminate

longstanding, bipartisan programs like the Community Development Block Grant, HOME, Fair Housing Initiatives, and NeighborWorks America, while also slashing \$26.7 billion from rental assistance and proposing a shift to state block grants.<sup>5</sup> These cuts are a direct threat to families, the elderly, and people with disabilities who rely on the federal government to protect their sole housing option. Congress can reject Trump's efforts that make it worse by promptly appropriating \$150 billion and finally addressing the affordable housing and homelessness crises.

Housing is the number-one domestic issue our country faces and as such, we request that in addition to regular appropriations, you include emergency housing investments to address the full spectrum of the worsening housing crisis. These funds represent what is needed to begin digging the nation out of a chronic undersupply of housing to help bring down housing costs, reduce homelessness, and revive the dream of homeownership for all. In particular, we'd like to highlight the requested funding for Emergency Housing Vouchers (EHVs). While \$8 billion is needed to fully meet growing need across the country, there are nearly 60,000 EHVs currently being leased by families who were previously experiencing or at risk of homelessness. However, due to both the success of the program as well as the nature of rising rental prices, the funding we secured in the American Rescue Plan Act for the first-of-its-kind EHV program has been fully awarded to public housing authorities (PHAs) and HUD estimates that after calendar year 2026, funds will have been fully spent down. If the Committee is unable to meet the \$8 billion request, we ask for full funding to renew 60,000 EHVs for FY26.
