4 Section 1024(b)(3) of the Consumer Financial Pro-5 tection Act of 2010 (12 U.S.C. 5514(b)(3)) is amended— 6 (1) by striking "regulators and the State bank regulatory authorities" and inserting "regulators, 7 8 the State bank regulatory authorities, and the State 9 agencies that licence, supervise, or examine the of-10 fering of consumer financial products or services"; 11 and

12 (2) by adding at the end the following: "The 13 sharing of information with such regulators, authori-14 ties, and agencies shall not be construed as waiving, 15 destroying, or otherwise affecting any privilege such 16 person may claim with respect to such information 17 under Federal or State law as to any person or enti-18 ty other than such Bureau, agency, supervisor, or 19 authority.".
