3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Appropriate Funding

## 1 SEC. 2. MINIMUM FSOC STAFFING LEVELS.

- 2 (a) MINIMUM STAFFING LEVEL.—Section 111 of the
- 3 Financial Stability Act of 2010 (12 U.S.C. 5321) is
- 4 amended by adding at the end the following:
- 5 "(k) Minimum Staffing Level.—The Chairperson
- 6 of the Council shall ensure that the Council has not less
- 7 than 36 full-time equivalent positions, not including any
- 8 employees detailed pursuant to subsection (j). At the end
- 9 of the 5-year period beginning on the date of enactment
- 10 of this subsection, and every 5 years thereafter, the num-
- 11 ber of full-time equivalent positions required by the pre-
- 12 vious sentence shall treated as increased by 5.".
- 13 (b) MINIMUM STAFF FUNDING LEVELS.—Section
- 14 118 of the Financial Stability Act of 2010 (12 U.S.C.
- 15 5328) is amended to read as follows:
- 16 "SEC. 118. COUNCIL FUNDING.
- 17 "(a) In General.—The Office of Financial Re-
- 18 search shall transfer to the Council the amount of funds
- 19 necessary to pay for the expenses of the Council, and the

- 21 "(b) Minimum Staff Funding Levels.—The Of-
- 22 fice of Financial Research shall transfer not less than
- 23 \$8,500,000 to the Council each year to pay for the staffing
