#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Aligning SEC Regula-

- 5 tions for the World Bank's International Development As-
- 6 sociation Act".

# 1SEC. 2. EXEMPTION OF SECURITIES OF THE INTER-2NATIONAL DEVELOPMENT ASSOCIATION3FROM THE SECURITIES LAWS.

4 (a) IN GENERAL.—The International Development
5 Association Act (22 U.S.C. 284–284cc) is amended by
6 adding at the end the following:

## 7 "SEC. 32. EXEMPTION FROM SECURITIES LAWS; REPORTS 8 REQUIRED.

9 "(a) EXEMPTION FROM SECURITIES LAWS; REPORTS TO SECURITIES AND EXCHANGE COMMISSION.—Any secu-10 rities issued by the Association (including any guaranty 11 by the Association, whether or not limited in scope) and 12 any securities guaranteed by the Association as to both 13 principal and interest shall be deemed to be exempted se-14 curities within the meaning of section 3(a)(2 of the Securi-15 ties Act of 1933 (15 U.S.C. 77c(a)(2)) and section 16 17 3(a)(12) of the Securities Exchange Act of 1934 (15) U.S.C. 78c(a)(12)). The Association shall file with the Se-18 19 curities and Exchange Commission such annual and other 20 reports with regard to such securities as the Commission 21 shall determine to be appropriate in view of the special 22 character of the Association and its operations and nec-23 essary in the public interest or for the protection of inves-24 tors.

25 "(b) AUTHORITY OF SECURITIES AND EXCHANGE26 COMMISSION TO SUSPEND EXEMPTION; REPORTS TO

CONGRESS.—The Securities and Exchange Commission, 1 2 acting in consultation with the National Advisory Council on International Monetary and Financial Problems, is au-3 4 thorized to suspend the provisions of subsection (a) of this 5 section at any time as to any or all securities issued or guaranteed by the Association during the period of such 6 7 suspension. The Commission shall include in its annual 8 reports to the Congress such information as it shall deem 9 advisable with regard to the operations and effect of this 10 section."".

(b) EFFECTIVE DATE.—The amendment made by
subsection (a) shall take effect 30 days after the date of
the enactment of this Act.
