

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 7128
OFFERED BY MR. FLOOD OF NEBRASKA**

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “TRIA Program Reau-
3 thorization Act of 2026”.

4 SEC. 2. EXTENSION.

5 Section 108(a) of the Terrorism Risk Insurance Act
6 of 2002 (15 U.S.C. 6701 note) is amended by striking
7 “2027” and inserting “2034”.

8 SEC. 3. IMPROVEMENTS TO CERTIFICATION PROCESS.

9 Section 102(1) of the Terrorism Risk Insurance Act
10 of 2002 (15 U.S.C. 6701 note) is amended—

11 (1) in subparagraph (B)—

12 (A) in clause (i), by striking “or” at the
13 end;

14 (B) in clause (ii), by striking “exceed
15 \$5,000,000.” and inserting: “exceed—

16 “(I) with respect to an act that

17 occurred in a year before 2029,

18 \$5,000,000; and

1 “(II) with respect to an act that
2 occurred in 2029, or any year there-
3 after, \$10,000,000”; and

4 (C) by adding at the end the following:

5 “(iii) the Secretary did not certify
6 such act as an act of terrorism before the
7 expiration of the 90-day period following
8 the publication of a notice in the Federal
9 Register under subparagraph (D)(i.”; and

10 (2) by striking subparagraph (D) and inserting
11 the following:

12 “(D) NOTICE REQUIREMENTS.—

13 “(i) IN GENERAL.—The Secretary
14 shall, not later than 30 days after begin-
15 ning the process of determining whether to
16 certify an act as an act of terrorism, pub-
17 lish a notice in the Federal Register that
18 informs the public that the Secretary is in
19 the process of determining whether to cer-
20 tify the act as an act of terrorism.

21 “(ii) ADDITIONAL NOTICE PER-
22 MITTED.—The Secretary may, as the Sec-
23 retary determines appropriate, notify the
24 public, through publication in the Federal
25 Register, or otherwise, that an act is not

1 being evaluated by the Secretary to deter-
2 mine whether it should be certified as an
3 act of terrorism.”.

4 SEC. 4. TECHNICAL AMENDMENTS.

5 (a) IN GENERAL.—Section 103(e)(7)(E)(i) of the
6 Terrorism Risk Insurance Act of 2002 (15 U.S.C. 6701
7 note) is amended—

8 (1) in subclause (I)—

11 (B) by striking “2024” and inserting
12 “2031”;

13 (2) in subclause (II)—

14 (A) by striking "2023" and inserting
15 "2030";

16 (B) by striking "2029" and inserting
17 "2036"; and

18 (C) by striking “2024” and inserting
19 “2031”; and

20 (3) in subclause (III)—

21 (A) by striking "2029" and inserting
22 "2036"; and

23 (B) by striking “2024” and inserting
24 “2031”.

1 (b) TECHNICAL CORRECTION.—The Terrorism Risk
2 Insurance Act of 2002 (15 U.S.C. 6701 note) is amended
3 by striking “Terrorism Insurance Program” each place it
4 appears and inserting “Terrorism Risk Insurance Pro-
5 gram”.
