A BILL

To authorize appropriations for the Community Development Financial Institutions Fund providing financial assistance and technical assistance for the benefit of certain minority communities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. COMMUNITY DEVELOPMENT FINANCIAL INSTI-**
4 **TUTIONS FUND.**

5 (a) IN GENERAL.—There is authorized to be appro-
6 priated to the Community Development Financial Institu-
7 tions Fund, out of amounts in the general fund not other-

1 wise appropriated, \$5,000,000,000 for fiscal year 2020,
2 for providing financial assistance and technical assistance
3 under subparagraphs (A) and (B) of section 108(a)(1) of
4 the Community Development Banking and Financial In-
5 stitutions Act of 1994 (12 U.S.C. 4707(a)(1)), except that
6 subsections (d) and (e) of such section 108 shall not apply
7 to the provision of such assistance, for the Bank Enter-
8 prise Award program, and for financial assistance, tech-
9 nical assistance, training, and outreach programs designed
10 to benefit Native American, Native Hawaiian, and Alaska
11 Native communities and provided primarily through quali-
12 fied community development lender organizations with ex-
13 perience and expertise in community development banking
14 and lending in Indian country, Native American organiza-
15 tions, Tribes and Tribal organizations, and other suitable
16 providers. Of the amount appropriated pursuant to this
17 heading, not less than \$2,000,000,000 shall be for pro-
18 viding financial assistance, technical assistance, awards,
19 training, and outreach programs described above to recipi-
20 ents that are minority lending institutions.

21 (b) DEFINITIONS.—For purposes of this section:

22 (1) MINORITY LENDING INSTITUTION.—The
23 term “minority lending institution” means any de-
24 pository institution, loan fund, or other financial in-
25 stitution that—

1 (A) if a privately-owned institution, 51 per-
2 cent is owned by one or more socially and eco-
3 nomically disadvantaged individuals;

4 (B) if publicly-owned, 51 percent of the
5 stock is owned by one or more socially and eco-
6 nomically disadvantaged individuals; and

7 (C) in the case of a mutual institution,
8 where the majority of the Board of Directors,
9 account holders, and the community which it
10 services is predominantly minority.

11 (2) MINORITY.—The term “minority” means
12 any black American, Native American, Hispanic
13 American, or Asian American.
