
In accordance with Clause 2(j)(1) of Rule XI of the Rules of the House, and Clause (d)5 of Rule 3 of the Rules of the Committee on Financial Services, we, the undersigned majority of the Minority members of the Committee, write to notify you of our intent to call additional witnesses selected by Committee Democrats to testify in continuation of the Full Committee hearing entitled, "American Innovation and the Future of Digital Assets: From Blueprint to a Functional Framework." Continuing this hearing with a second panel, also known as a "Minority Day Hearing," in addition to the Wednesday, June 4, 2025, hearing panel, will provide Members of the Committee and the American public the opportunity to consider and discuss additional perspectives on President Trump's crypto conflicts of interest and corruption, including measures like H.R. 3573, the Stop TRUMP in Crypto Act to address such conflicts and corruption; the effects of H.R. 3633, the Digital Asset Market Clarity (CLARITY) Act of 2025, on consumer and investor protection, national security, and existing securities and commodity futures regulation; and the potential effects of the proposed legislation on the digital asset industry and broader financial system.

Given that the Committee may consider the CLARITY Act of 2025 as soon as next week as part of the Full Committee's Tuesday, June 10, 2025, markup, we request that this hearing be scheduled this week.
